4.B FINAL REPORT FROM THE RISK ANALYSIS OF THE RUNWAYS AT ORLANDO INTERNATIONAL AIRPORT (MCO)

In 2013 the Greater Orlando Aviation Authority (GOAA) retained Applied Research Associates, Inc, to conduct a Runway Safety Area (RSA), Runway Protection Zone (RPZ), and Airfield Risk Analysis on all four runways at MCO. Attached is the final report, in conjunction with the related study *Airfield Safety Areas and Runway Critical Surfaces Evaluation* (found in **Appendix 4.A**), that supported the Aviation Authority's Airport planning coordination activities with the FAA.
